Or if the sale from any location or source comes back to the gallery to be rung up, Omni also gets a percent. If the artwork is hung, purchased, and paid for off premises no Omni percentage is paid.

It was determined that according to the agreement with the Omni, we must pay the required 32% of sales to the Omni from this event.

Ed reminded us of the idea approved at the November meeting to generate funds for the gallery:

Implement a voluntary exhibiting member art donation event. Current exhibiting artists donate an art piece to be sold with all the proceeds donated to the gallery. This would be a personal choice to donate or not. The idea, if approved by the board, will be presented to the exhibiting membership for approval at the January 14, 2019 general meeting as stated at the November meeting minutes.
