The expected plan is to return the Point-of-Sale System because of reporting problems. The company could not guarantee the problems could be fixed in the probationary time period. The reports presented problems to our treasurer. One of the issues was they inflated our revenues. Feedback was good on the training process with the artists. Other systems will be identified and researched.

The next rehang is July 12, 2021. Paintings should be brought to the gallery between 8:00 am and 10:00 on Monday July 12th. Rehang will begin at 10:00. Please be prompt so as not to disrupt the hanging committee in their work.
